NOTIFICATION OF THE FOOD AND DRUG ADMINISTRATION RE: PRESCRIBING THE FORMS OF APPLICATION AND LICENSE TO PRODUCE, IMPORT OR SELL HERBAL PRODUCT, B.E. 2563 (2020)*

By virtue of the provisions in clause 2, clause 7, clause 9, clause 10, clause 11, and clause 13 of the Ministerial Regulation on Application for License and Issuance of License to Produce, Import or Sell Herbal Product, B.E. 2563 (2020), issued under the Herbal Products Act, B.E. 2562 (2019), the Secretary-General of the Food and Drug Administration hereby issues a Notification as follows:

- **Clause 1.** This Notification shall come into force as from the day following the date of its publication in the Government Gazette.
- Clause 2. Any person who wishes to apply for license to produce, import or sell herbal product shall submit an application together with documents or evidence in accordance with the HP.1 form annexed to this Notification.
- **Clause 3.** License to produce, import or sell herbal product shall be in accordance with the HP.2 form annexed to this Notification.
- **Clause 4.** A licensed producer, importer or seller of herbal product who wishes to vary a particular on the license to produce, import or sell herbal product, as the case may be, shall submit an application together with documents or evidence in accordance with the HP.3 form annexed to this Notification.
- **Clause 5.** A profession practitioner, practitioner of healing arts or any career whose duty is to produce, import or sell herbal products shall submit a certification together with documents or evidence in accordance with the HP.4 form annexed to this Notification.

- **Clause 6.** A licensed producer, importer or seller of herbal product who wishes to apply for license renewal shall submit an application together with documents or evidence in accordance with the HP.5 form annexed to this Notification.
- **Clause 7.** A licensed producer, importer or seller of herbal product who wishes to apply for a license substitute shall submit an application together with documents or evidence in accordance with the HP.6 form annexed to this Notification.
- **Clause 8.** A licensed producer, importer or seller of herbal product who wishes to apply for license transfer shall submit an application together with documents or evidence in accordance with the HP.7 form annexed to this Notification.
