## NOTIFICATION OF THE MINISTRY OF PUBLIC HEALTH RE: IMPORT INSPECTION CHECKPOINTS FOR HERBAL PRODUCTS<sup>\*</sup>

By virtue of the provisions in section 5 paragraph one and section 6 (15) of the Herbal Products Act, B.E. 2562 (2019), the Minister of Public Health, with the recommendation of the Herbal Product Committee at the meeting No.5/2562 on 26<sup>th</sup> December B.E. 2562 (2019), hereby issues the Notification as follows:
