

**MINISTERIAL REGULATION**  
**PRESCRIBING FEES, REDUCTION OF AND EXEMPTION FROM FEES**  
**FOR ACTIVITIES IN RELATION TO HERBAL PRODUCTS,**  
**B.E. 2563 (2020)\***

By virtue of the provision in section 5 paragraph one of the Herbal Products Act, B.E. 2562 (2019), the Minister of Public Health hereby issues the Ministerial Regulation as follows:

**Clause 1.** Fees shall be prescribed as follows:

**Clause 2.** The rate of fees under clause 1 shall be reduced by one-half for producers or sellers who are business operators under section 10 (8) who have notified the Director-General for the application for the promotion under section 77.

**Clause 3.** The rate of fees under clause 1 shall be exempted by producers or sellers who are business operators under section 10 (8) who have notified the Director-General for the application for the promotion under section 77.

the Minister of Public Health shall have the power to issue Ministerial Regulation prescribing the fees not exceeding the rate of fees annexed to the Act and prescribing the reduction of or exemption from the fees, it is therefore necessary to issue this Ministerial Regulation.
